INTERNATIONAL STUDENT TRANSFER FORM

Each international student applicant who is applying to St. Tikhon's Orthodox Theological Seminary and is attending a U.S. high school, college, university or English language institute must submit this International Student Transfer Form in addition to official transcripts of grades/performance reports. Please forward this form to the appropriate office or person (usually the DSO / International Student Advisor) at your school for completion. Your signature indicates you are giving permission to answer the questions below. This report is a necessary part of your application to St. Tikhon's Orthodox Theological Seminary.

The Family Education Rights and Privacy Act of 1974, as amended (P.L. 93-380), allows a candidate for admission to waive his or her right of access to confidential letters or statements written in his or her behalf if the recommendation is used solely for the purposes of admission, and if the candidate, upon request, is notified of the names of all persons making such a recommendation on his or her behalf. The Seminary does not require that you make such a waiver as a condition for admission. However, under the legislation you have the option of signing such a waiver as follows:

I do do not waive my right of access to this recommendation and any appropriate attachments in behalf of my application for admission to St. Tikhon's Orthodox Theological Seminary. This waiver is effective insofar as the recommendation is used solely for the purpose of admission.
